TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made as of May 1, 2018 ("Effective Date"), by and between TREKPAK LLC, a Colorado limited liability company, with a principal place of business at 2400 Industrial Lane, Ste. 2200, Broomfield, CO 80020 ("Seller"); and PELICAN PRODUCTS, INC., a Delaware corporation, with its principal place of business at 23215 Early Avenue, Torrance, CA 90505 ("Purchaser").

WHEREAS, the parties entered into that certain Intellectual Property Transfer Agreement, dated May 1, 2018 (the "Intellectual Property Transfer Agreement");

WHEREAS, under the Intellectual Property Transfer Agreement, among other things, Seller has agreed to assign its rights in and to the Transferred Trademarks (as such term is defined in the Intellectual Property Transfer Agreement) to Purchaser;

WHEREAS, Seller assigns, and Purchaser accepts the assignment of, the Transferred Trademarks, under the terms and conditions set forth below;


NOW, THEREFORE, in consideration of the foregoing and the covenants and promises contained herein, the parties agree as follows:

1. Seller does hereby sell, assign, transfer, convey and deliver to Purchaser, free and clear of any liens, all of Seller's right, title and interest in and to the Transferred Trademarks, including, without limitation, those trademarks and trademark applications listed on Schedule A to this Assignment, along with the goodwill connected with the use thereof and symbolized thereby, the same to be held by Purchaser for Purchaser's own use and enjoyment, and for the use and enjoyment of Purchaser's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this assignment and sale had not been made, and all claims for damages and other remedies for past and future infringements of the Transferred Trademarks, along with the right to sue for and collect such damages and other remedies for the use and benefit of Purchaser and its successors, assigns and other legal representatives.

2. Seller agrees to execute and deliver such other documents and to take all such other actions which Purchaser, its successors and assigns may request to effect the terms of this Assignment, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required to effect the terms of this Assignment and its recordation in relevant state, national or international trademark offices.


