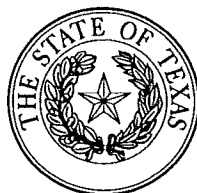

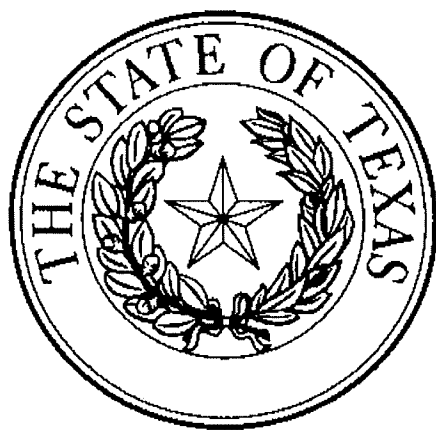

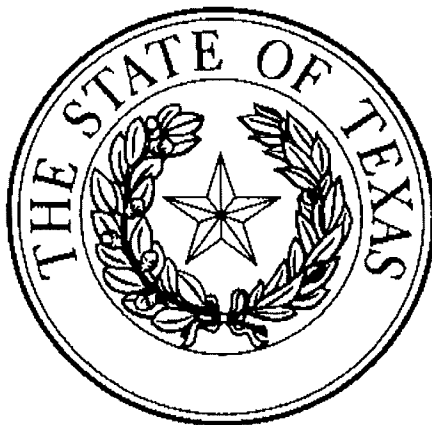

7. The Plan of Conversion has been approved as required by the laws of the State of Texas and the governing documents of the Corporation. In lieu of providing the certificate from the Comptroller of Public Accounts that all taxes under Title 2, Tax Code have been paid, the LLC is liable for the payment of any franchise taxes.

8. This Certificate of Conversion shall become effective when filed accepted and filed by the Texas Secretary of State.

The undersigned natural person of the age of eighteen (18) years or more, acting as an organizer of a limited liability company under the Texas Business Organizations Code (the "TBOC"), hereby adopts the following Certificate of Formation for such limited liability company:

1. The name of the limited liability company is 1 Priority Environmental Services, LLC (the "Company"). The Company is a limited liability company.

2. The period of duration of the Company shall be perpetual, unless it is earlier wound up in accordance with the provisions of the Company Agreement of the Company.

3. The purpose for which the Company is organized is to transact any and all lawful business for which a limited liability company may be organized under the TBOC.

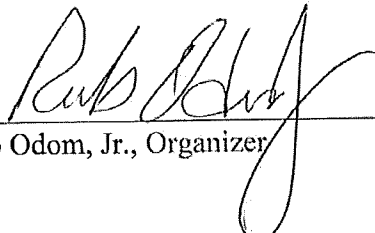
