## SECOND LIEN RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Second Lien Release of Security Interest in Trademarks ("Trademark Release") is made as of May 7, 2018, by MORGAN STANLEY SENIOR FUNDING, INC., a Delaware corporation, as Collateral Agent (together with its successors and assigns in such capacity, the "Collateral Agent") in favor of CONTINENTAL PACKAGING SOLUTIONS, INC., a Delaware corporation with an address at 525 West Monroe Street, 14<sup>th</sup> floor, Chicago, Illinois 60661 (the "Pledgor").

WITNESSETH

WHEREAS, Pledgor and Collateral Agent entered into a certain Notice of Grant of Security Interests in Trademarks dated October 1, 2014 (the "Trademark Security Agreement"), notice of which was recorded by the United States Patent and Trademark Office on October 2, 2014 at Reel 5373, Frame 0286.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in all of such Pledgor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed in Schedule A.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgor, and assigns, transfers and conveys to Pledgor any interest in such intellectual property, including the Security Interest.
