**NOTICE OF RELEASE OF
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

WHEREAS, by a Trademark Security Agreement for Recordation, dated as of July 30, 1999, and recorded in the United States Patent and Trademark Office on August 11, 1999, at Reel 1943, Frame 0795 (the "Trademark Security Agreement"), **KISS NAIL PRODUCTS, INC.**, New York corporation ("Assignor") granted and assigned to **JPMORGAN CHASE BANK, N.A.** (formerly known as JPMorgan Chase Bank, which was formerly known as The Chase Manhattan Bank), as administrative agent for the benefit of the Lenders (as hereinafter defined) (the "Secured Party") a lien upon and security interest in all of the rights, title and interest of the Assignor in and to the trademarks and trademark applications listed on Schedule A (the "Trademarks");



IN WITNESS WHEREOF, this Notice of Release of Security Interest in United States Trademarks has been executed as of April 26, 2018.


