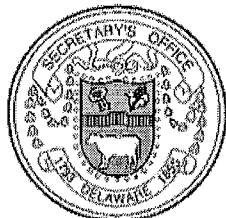

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is YALE SECURITY INC., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is ROCKWOOD MANUFACTURING COMPANY, a PENNSYLVANIA corporation.

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.
