PATENT AND TRADEMARK RELEASE AND REASSIGNMENT

THIS PATENT AND TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of May 8, 2015, by General Electric Capital Corporation, as agent for the Secured Parties (in such capacity, “Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Aerostructures Acquisition LLC, a Delaware limited liability company (the “Debtor”) and Agent are parties to that certain Security Interest in U.S. Patents and Trademarks dated as of December 31, 2012 (the “Security Agreement”), pursuant to which the Debtor granted a security interest to Agent in the (i) Marks and Patents, (ii) all Proceeds of the Marks and Patents, (iii) the goodwill of the business with which the Marks are associated and (iv) all causes of action for infringement of any Marks and Patents or unfair competition regarding the same (the foregoing items (i) through (iv), the “IP Collateral”) as security for certain obligations owing by the Debtor to Agent and the Secured Parties, including the Marks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 15, 2014, at Reel 5192, Frame 0896; and

WHEREAS, the Debtor has requested that Agent release its security interest in the Marks and Patents and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates the Security Agreement and releases its security interest in all of the Debtor’s right, title and interest in and to the IP Collateral, including the Marks set forth on Schedule 1 hereto.
2. Agent hereby reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the IP Collateral.
3. Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.
