TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST --  
TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS ("Termination and Release") dated as of May 8, 2018, from CERBERUS BUSINESS FINANCE, LLC, as collateral agent (the "Agent") to MAVENIR SYSTEMS, INC. and MAVENIR SYSTEMS, INC. (formerly known as Ulticom, Inc.) (the "Grantors"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Financing Agreement, the U.S. Pledge and Security Agreement or the Grant of a Security Interest -- Trademarks, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain U.S. Pledge and Security Agreement dated as of August 19, 2016 and that certain Security Agreement Supplement dated February 28, 2017, the Grantors executed a Grant of a Security Interest -- Trademarks dated as of February 28, 2017, which was recorded in the United States Patent and Trademark Office at Reel 006000, Frame 0864, pursuant to which the Grantors granted a security interest to the Agent, for the benefit of the Secured Parties, in the Collateral and Trademarks, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Collateral and Trademarks and reassign any and all rights, title, and interest in the same to Grantors.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantors' right, title and interest in and to the Collateral and Trademarks, including those trademarks set forth on Schedule A.

2. Agent hereby assigns, grants and conveys to the Grantors, without any representation, warranty, recourse or undertaking by the Agent, any and all of Agent's right, title, and interest in and to the Collateral and Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof.
