RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of May 11, 2017 (the "Effective Date") by ALLIANCE BANK OF ARIZONA, a division of Western Alliance Bank ("Secured Party"), in favor of CRANIAL TECHNOLOGIES, INC., an Arizona corporation (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Loan Agreement, dated as of December 23, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), between the Grantor and the Secured Party, Grantor agreed to grant to the Secured Party a security interest in substantially all of the intellectual property assets of Grantor;

WHEREAS, pursuant to the Loan Agreement, the Grantor and the Secured Party executed an Intellectual Property Security Agreement dated as of December 23, 2011 (the "IPSA"), to record the security interest with respect to the Trademarks (as defined in the IPSA) (such Trademarks, including, for the avoidance of doubt, the Trademark registrations and applications set forth in Schedule I attached hereto, together with the goodwill associated therewith and all products and proceeds of the foregoing, collectively, the "Trademark Collateral") of Grantor, which was recorded with the Trademark Division of the U.S. Patent & Trademark Office on January 9, 2012, at Reel 4694 and Frame 0128;

WHEREAS, the IPSA was also entered into to record the security interest with respect to the Patents (as defined in the IPSA) (such Patents, including, for the avoidance of doubt, the Patents and Patent applications set forth in Schedule II attached hereto, together with all products and proceeds of the foregoing, collectively, the "Patent Collateral") of Grantor, which was recorded with the Patents Division of the U.S. Patent & Trademark Office on January 9, 2012, at Reel 027500 and Frame 0033;

WHEREAS, the IPSA was also entered into to record the security interest with respect to the Copyrights (as defined in the IPSA) (such Copyrights, including, for the avoidance of doubt, the Copyright registrations and applications set forth in Schedule III attached hereto, together with all products and proceeds of the foregoing, collectively, the "Copyright Collateral") of Grantor, which was recorded with the U.S. Copyright Office at Volume 3612 and Document No. 215;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates the IPSA and the Loan Agreement, and hereby terminates, cancels, re-pledges, and releases to the Grantor any and all liens and security interests it has against the Trademark Collateral, the Patent Collateral and the Copyright Collateral, and all proceeds of any and all of the foregoing.

If and to the extent the Secured Party has acquired any right, title or interest to any of the Trademark Collateral, the Patent Collateral or the Copyright Collateral, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

The Secured Party shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed exclusively under the laws of the State of Arizona without regard to conflicts of law or choice of law principles.
