TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment") is made as of March 19, 2018 (the "Effective Date") between Advanced Ear, Nose & Throat Specialists, S.C., a Wisconsin corporation ("Assignor"), and Adventist Health System Sunbelt Healthcare Corporation, a Florida corporation ("Assignee"). All capitalized terms not defined herein shall have the meaning assigned to such terms in the APA (as defined below). Assignor and Assignee are sometimes referred to individually herein as a "Party" and collectively as the "Parties."

RECITALS

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of March 19, 2018 (the "APA"); and

WHEREAS, pursuant to the APA, Assignor and Assignee desire for Assignor to assign and transfer the Marks (as defined below) together with the goodwill associated with the Marks to Assignee.

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants and agreements contained in this Trademark Assignment, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Trademark Assignment. Pursuant to and subject to the terms and conditions of this Trademark Assignment, Assignor hereby assigns and transfers to Assignee all right, title and interest in and to the marks listed in Exhibit A, including the federal trademark registrations and applications and common law rights therefor, as well as Assignor's trade name rights in the name "Advent" and any colorable derivative thereof (collectively, the "Marks") together with all of the goodwill of Assignor's business connected with it as it pertains to the use of and is symbolized by the Marks, and any and all claims for damages by reason of past and future infringement of the Marks, whether known or unknown, together with the rights to sue and collect damages therefor. Assignor also hereby assigns and transfers to Assignee and its representatives, successors and assigns Assignor's entire rights, title and interest in and to any and all U.S. or foreign applications arising out of the Marks, including all rights under any and all international conventions and treaties respecting the Marks in foreign countries. Assignor further authorizes Assignee to apply for protection of the Marks in the U.S. or in foreign countries directly in Assignee's own name, and to claim priority of the Marks.

2. Representations and Warranties of the Parties. Each Party hereby warrants that (a) it has full power and authority to enter into and perform its obligations under this Trademark Assignment in accordance with its terms, and (b) it is and will remain free of any obligations and restrictions that would prevent or impede its performance of its obligations under this Trademark Assignment.

3. Further Assurances. Each Party shall, without additional consideration, take such further actions and execute promptly such further documents as are reasonably requested by the other Party to effect and record the assignment and transfer of the Marks.

4. Recording of Assignment. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, if necessary, and any officer of any country or countries foreign to the United States, whose duty it is to issue trademarks or other evidence or forms of intellectual property protection or applications, to issue the same to Assignee and Assignee's successors, assigns and other legal representatives in accordance with the terms of this Trademark Assignment.

5. Governing Law; Venue. This Trademark Assignment shall be governed by and constructed in accordance with the laws of the State of Florida. Any dispute arising under or in connection with this Trademark Assignment shall be resolved in the federal or state courts in and for the county in which the party not bringing the dispute is located, without regards to conflict of law principles, and the parties hereby submit to the exclusive jurisdiction of such courts in respect of any such proceeding.

6. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall for all purposes be deemed to be an original and all of which shall constitute the same instrument. Counterpart signature pages to this Agreement transmitted by facsimile transmission, by electronic mail in portable document format form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing an original signature. An electronic or facsimile signature by any person on a counterpart of this Trademark Assignment shall be binding and effective for all purposes.
