RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release"), dated as of February 7, 2018, is entered into by and between CIBC Bank USA, formerly known as The PrivateBank and Trust Company ("Secured Party"), and OGI, LLC, a Delaware limited liability company (the "Company").

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement, dated April 25, 2017, by the Company in favor of Secured Party (the "Trademark Security Agreement"), the Company collaterally assigned to Secured Party its entire right, title, and interest in, among other trademarks, the trademark identified as "Eyeglass Design", registration number 3,689,188 (the "Trademark"); and

WHEREAS, Secured Party has agreed to terminate and release its security interest in the Trademark as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and the Company hereby agree as follows:

1. Release. Secured Party hereby releases its security interest in and first priority lien on the Trademark. For the avoidance of doubt, nothing herein shall constitute a release or termination by Secured Party of any other trademarks collaterally assigned to Secured Party pursuant to the Trademark Security Agreement.

2. Acknowledgment. The Company hereby acknowledges the foregoing release by Secured Party.

3. Counterparts. This Release may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall be deemed to be one Release. This Release, to the extent signed and delivered by means of a facsimile machine or via electronic mail of a .pdf or .tif or similar file format, shall be treated in a manner and in all respects as an original agreement or instrument and shall be considered to have the same binding legal effect as if it were the original signed version thereof delivered in person.



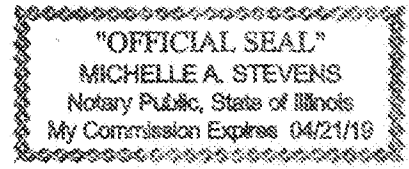
