NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

WHEREAS, reference is made to that certain Loan and Security Agreement, dated as of June 30, 2016 (as amended, restated, amended and restated, modified or supplemented, the "Loan and Security Agreement") by and between Siena Lending Group LLC ("Lender") and American Bare Conductor, Inc. ("Borrower");

WHEREAS, in accordance with the terms and conditions of the Loan and Security Agreement, the Borrower executed that certain Intellectual Property Security Agreement dated as of June 30, 2016 (as amended, restated, amended and restated, modified or supplemented, the "IP SA"), recorded with the United States Patent and Trademark Office on July 5, 2016 at Reel 5825, Frame 0001, pursuant to which the Borrower granted to the Lender a security interest in all right, title and interest of the Borrower in and to the trademarks and trademark registrations and applications therefore listed on Schedule A hereto (the "Trademarks");

WHEREAS, in accordance with the provisions of the Loan and Security Agreement, the Lender wishes to terminate the IP SA and release the security interest in the Trademarks and provide a document suitable for recording in the United States Patent and Trademark office and other applicable filing office(s), domestic and foreign, for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks;


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Lender hereby terminates, relinquishes, releases and discharges its security interest in all of the Borrower's right, title and interest in the Trademarks, including but not limited to (w) all goodwill associated with or symbolized by the foregoing; (x) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Lender accruing thereunder or pertaining thereto, (y) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and (z) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Trademarks of or arising from any of the foregoing.


The Lender authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Notice of Release.

This Notice of Release shall be governed by, and construed in accordance with, the laws of the State of New York.


