INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (this "**Agreement**") is entered into as of March 5, 2018, by Anthem Wrestling Exhibitions, LLC, a Delaware limited liability company ("**Debtor**"), in favor of 10007766 Manitoba Inc., a corporation organized under the laws of Manitoba ("**Collateral Agent**"), in its capacity as Collateral Agent under the Security Agreement (as defined below).

RECITALS:

A. Pursuant to the Notes dated as of the date hereof by and among Debtor, Collateral Agent, and the "Makers" named therein (the "**Notes**") (capitalized terms not otherwise defined herein have the meanings provided in the Notes), Makers have agreed to extend credit to Debtor, on certain terms and conditions.

B. Debtor has granted to Collateral Agent a security interest in all of its personal property and fixtures pursuant to that Security Agreement dated as of the date hereof among Debtor, the Makers and Collateral Agent (the "**Security Agreement**").

C. Debtor wishes to execute this Agreement to supplement the terms of the Security Agreement and to place of record Debtor's grant of a security interest to Collateral Agent in Debtor's registered intellectual property in the United States.

AGREEMENT:

NOW THEREFORE, as an inducement to cause Makers to extend credit to Debtor, and for other valuable consideration, the receipt and sufficiency of which are acknowledged, it is agreed as follows:

UCC Security Interest in Registered Property. As security for Debtor's obligations under the Notes, Debtor hereby grants to Collateral Agent a security interest in the registered intellectual property described in Schedule A hereto.

Recordation. Debtor hereby authorizes Collateral Agent to record this Agreement with the United States Copyright Office, the United States Patent and Trademark Office, or such other governmental authority, as reasonably necessary to for the intellectual property described on Schedule A hereto.


Other Agreements. This Agreement is executed to supplement and further evidence the security interest granted to Collateral Agent under the Security Agreement. The rights and remedies of Collateral Agent with respect to the security interest granted hereby are in addition to those set forth in the Notes, the Security Agreement and the documents and instruments contemplated thereby, and those which are now or hereafter available to Collateral Agent as a matter of law or equity.
