FOR REGISTRATION 1863419 REEL AND FRAME 03872/ 0033

- 1) This Corrective Assignment is made to memorialize that the rightful owner of Registration Number 1,863,419 is **Protec International Limited**. This Corrective Assignment is additionally made to correct the false affidavits that were executed and subsequently Recorded on Reel and Frame Numbers 01952/0603, 03872/0033 and 005519/0004, without the consent or knowledge of the owner of Registration Number 1,863,419 ("The Registration"). The only true Assignment recorded against The Registration are the Assignment recorded on November 12, 1999 at Frame 1987, Reel 0263 and the Corrective Assignment recorded on May 16, 2000 at Frame 002044, Reel 0039 that convey Pro Tec USA, Inc.'s interest in The Registration to Protec International Limited.
- 2) My name is Werner Urban and I am Managing Director of Protec International Limited, successor in interest to Pro Tec USA, Inc.
- 3) On November 22, 1994, the mark PRO TEC (design) registered under The Registrations. At the time, the owner of that mark was Pro Tec USA, Inc.
- 4) Due to a series of fraudulent affidavits, the record currently reflects Protec Auto Care Limited as the owner of Registration Number 1,863,419. However, Protec International Limited is the rightful owner of The Registration.
- 5) Upon information and belief, on August 27, 1999, a third party executed a false Assignment conveying Registration Number 1,863,419 from Protec USA, Inc. to Protec International, Inc. The Assignment was subsequently recorded on September 3, 1999 at Frame 01952, Reel 0603. This Assignment was not prepared or recorded under the direction or, on behalf of, the rightful owner of The Registration. The recordation occurred unbeknownst to the rightful owner of The Registration.
- 6) On November 5, 1999, Pro Tec USA, Inc. executed an Assignment conveying its interests in The Registration to Protec International Limited. The Assignment was subsequently recorded on November 12, 1999 at Frame 1987, Reel 0263. A minor

correction was made and a Corrective Assignment was recorded on May 16, 2000 at Frame 002044, Reel 0039. These actions were taken under direction of Pro Tec USA, Inc, right rightful owner of The Registration. The Assignment recorded on November 12, 1999 at Frame 1987, Reel 0263 and the Corrective Assignment recorded on May 16, 2000 at Frame 002044, Reel 0039 are the only legitimate Assignments.

- 7) Upon information and belief, on October 16, 2008, a third party executed an additional false Assignment conveying Protec International Limited's interest in The Registration to Industrial Maintenance Products Limited. The Assignment was subsequently recorded on October 17, 2008 at Frame 03872, Reel 0033. This Assignment was not prepared or recorded under the direction or, on behalf of, the rightful owner of The Registration. The recordation occurred unbeknownst to the rightful owner of The Registration.
- 8) Upon information and belief, on November 20, 2008, a third party executed an additional false Assignment conveying to Industrial Maintenance Products Limited's interest in the Registration to Protec Autocare Limited. The Assignment was subsequently recorded on May 18, 2015 at Frame 005519, Reel 0004. This Assignment was not prepared or recorded under the direction or, on behalf of, the rightful owner of The Registration. The recordation occurred unbeknownst to the rightful owner of The Registration.
- 9) The record reflects the current owner to be Protec Autocare Limited. However, the chain of title should run from Protec USA, Inc. to Protec International, Inc. The true owner of Registration Number 1,863,419 is Protec International Limited.
