 Oregon.
- 2. Sand Dollar Holdings, Inc., by an agreement dated February 27, 1998 acquired all of the stock of AAS Holding Co., Inc. and thereby controlled the three AAS Holding Co., Inc. subsidiaries, including Western Boxed Meats Distributors, Inc. and Western Pride Meats, Inc.
- At the time of the stock acquisition by Sand Dollar Holdings, Inc., Western Pride Meats,
 Inc. owned US Registration 1,460,248 (the '248 Registration) for the mark Cattle Land.
- In 2002 Sand Dollar Holdings, Inc. caused the dissolution of Western Pride Meats, Inc.
 The State of Oregon records indicate that the dissolution was effective as of March 29, 2002.
- 5. Upon dissolution, Western Pride Meats, Inc.'s rights and good will in the mark Cattle Land and the '248 Registration became assets of Western Boxed Meats Distributors, Inc.; as confirmed by the continuous use of the Cattle Land mark for the goods of the '248 Registration since the dissolution of Western Pride Meats. Inc.


