RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE dated as of May 17, 2018 (this "Release") is made by CIT BANK, N.A. (formerly known as OneWest Bank N.A., as successor to OneWest Bank, FSB, "Lender") under that certain Intellectual Property Security Agreement, dated as of June 29, 2011 (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement") by OMNISYS, LLC, a Texas liability company (the "Grantor") with an address of 15950 Dallas Parkway Suite 350, Dallas, Texas, 75248 in favor of the Lender.

WHEREAS, pursuant to the IP Security Agreement which was recorded in the records of the United States Patent and Trademark Office on July 1, 2011 at reel 4574, frame 0131 the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral.
