## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is made and entered into as of the signature date below, by Citicorp USA, Inc., a national banking association ("Citicorp"), having a place of business at 388 Greenwich Street, 19<sup>th</sup> Floor, New York, New York 10013, in favor of ICL Performance Products LP, a Delaware limited partnership ("ICL PP"), with an address of 622 Emerson Road, Suite 500, St. Louis, Missouri 63141.

WHEREAS, the Security Interest was recorded in the United States Patent and Trademark Office on March 9, 2005 at Reel 3060, Frame 0572; and

WHEREAS, Astaris LLC ("Astaris"), the predecessor-in-interest to ICL PP, repaid all obligations under the Credit Agreement dated as of February 8, 2005, among Astaris, the Lenders and Issuers party thereto, and Citicorp, as agent for the Lenders and Issuers.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Citicorp hereby releases its liens and security interests and resigns any and all right, title, and interest it may have in and to the following property:

(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by of ICL PP against third parties for damages by reason of past, present or future

infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
