**TERMINATION AND RELEASE OF  
CONDITIONAL ASSIGNMENT AND TRADEMARK SECURITY AGREEMENT  
SUPPLEMENT NO. 1**

THIS TERMINATION AND RELEASE OF CONDITIONAL ASSIGNMENT AND TRADEMARK SECURITY AGREEMENT SUPPLEMENT NO. 1 (this "Termination"), dated as of May 15, 2018, is executed by Wells Fargo Bank, National Association (Successor to First Union National Bank), as administrative agent (the "Administrative Agent"), in favor of Wolf Camera, Inc., a Georgia corporation (the "Borrower"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

**RECITALS**

A. Pursuant to that certain Conditional Assignment and Trademark Security Agreement Supplement No. 1, dated as of August 25, 2000 (as amended, the "Security Agreement"), by and between Borrower and Administrative Agent, Borrower granted to Administrative Agent a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 27, 2000 at Reel/Frame 2161/0495 to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to execute this Termination in order to evidence the termination and release of its security interest in the IP Collateral specified below.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent's right, title and interest in, to and under the following (collectively, the "IP Collateral"):

(i) All "Trademarks" (as defined below), whether now owned or hereafter arising or acquired by Borrower, including each trademark identified on Schedule A hereto. For purposes of this Termination, "Trademarks" shall mean all trade names, trademarks, service marks and logos (registered or unregistered) and state, federal and foreign trademark and service mark registrations and state, federal and foreign registration applications (in use and intent to use) and all renewals and divisions thereof, all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, the right to recover for all past, present and future infringements thereof, all other rights of any kind whatsoever accruing thereunder or pertaining thereto, all rights corresponding thereto throughout the world, together, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such Trademark and all proceeds of the foregoing.

(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the trademark division of the United States Patent and Trademark Office to record this Termination.
