**WINCHESTER ELECTRONICS CORPORATION**, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"),

**DOES HEREBY CERTIFY:**

**FIRST:** That the Board of Directors of the Corporation, by the unanimous consent of its members, filed with the minutes of the board, duly adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that Article I of the Certificate of Incorporation is hereby deleted in its entirety and the following Article I is inserted in lieu thereof:

"The name of the Corporation is Winchester Interconnect Corporation."

**FOURTH:** That this Certificate of Amendment of the Certificate of Incorporation shall be effective as of November 30, 2017 at 11:59 p.m.
