TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement (the "Agreement") is entered into between United Parcel Service of America, Inc., a Delaware corporation ("UPS") and Coyote Logistics, LLC, a Delaware limited liability company ("Coyote").

WHEREAS, Coyote owns the trademark applications and registrations listed in Schedule 1, attached hereto (collectively, the "Marks"); and

WHEREAS, Coyote wishes to sell and assign to UPS, and UPS wishes to purchase from Coyote all of Coyote's right, title, and interest in and to the Marks, including all goodwill associated with the Marks;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Assignment.** Coyote sells and assigns to UPS all of Coyote's right, title, and interest to the Marks, including any causes of action relating to the Marks, claims for damages, profits and costs, both in equity and law, for any infringement or infringements of rights accruing in the Marks on or before the date of the Assignment, together with all goodwill associated with the Marks.
2. **Payment.** In full consideration of the rights granted in this Agreement, UPS will pay to Coyote the sum of One Hundred U.S. Dollars (\$100.00).
3. **Representations and Warranties.** Each of Coyote and UPS represents and warrants that the individual signing this Agreement on its behalf is fully authorized to do so. Coyote further represents and warrants that:
 - a. it has not granted any person or entity any currently-subsisting or future right, title, or interest in or to the Marks;
 - b. the Marks are not subject to any third-party lien or encumbrance;
4. **Entire Agreement.** This Agreement contains the entire understanding of the parties. This Agreement cannot be modified or otherwise changed except in a writing signed by both parties.
5. **Execution.** The Agreement may be executed in one or more counterparts, each of which will be deemed an original, all of which together will constitute one and the same instrument, without affecting the validity hereof. Scanned signatures shall be deemed binding for all purposes.

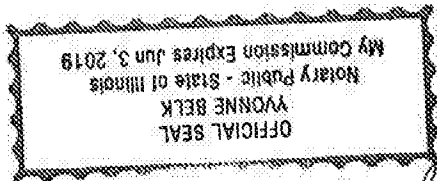

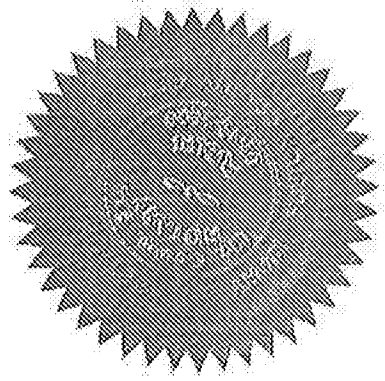


