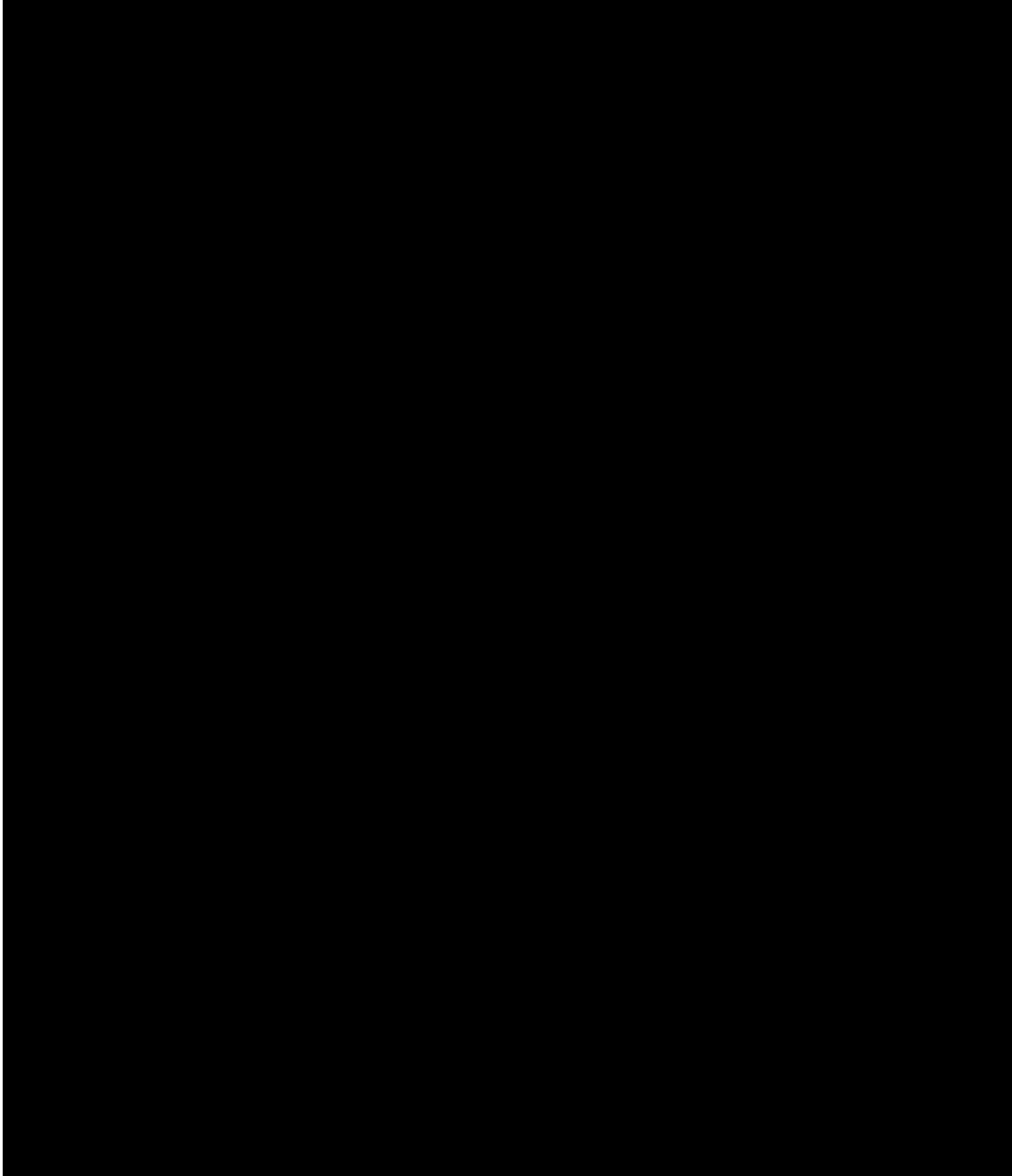

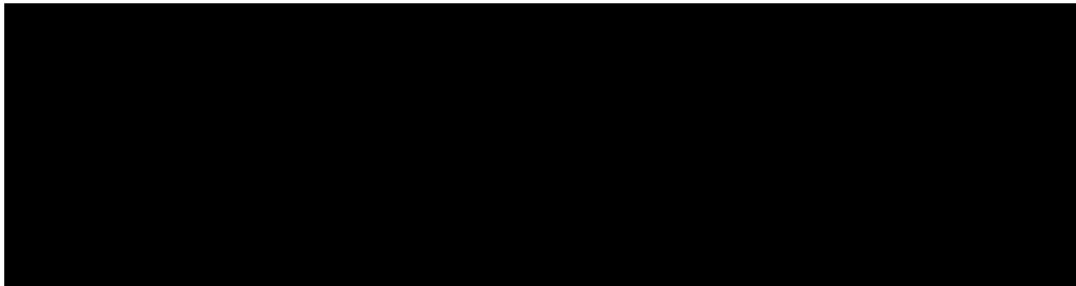

Article 2. Transfer and assignment of Kyphon IP

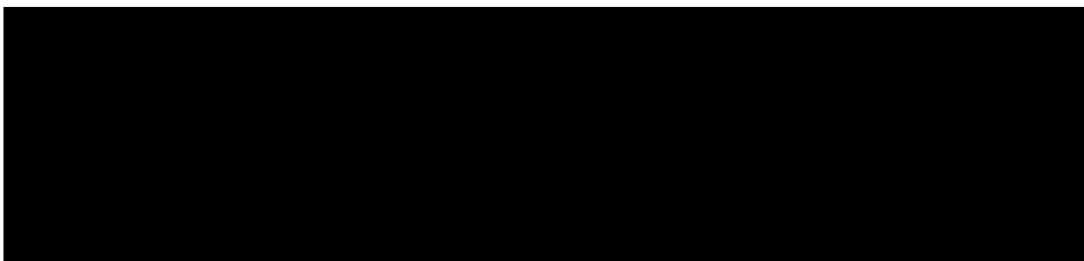

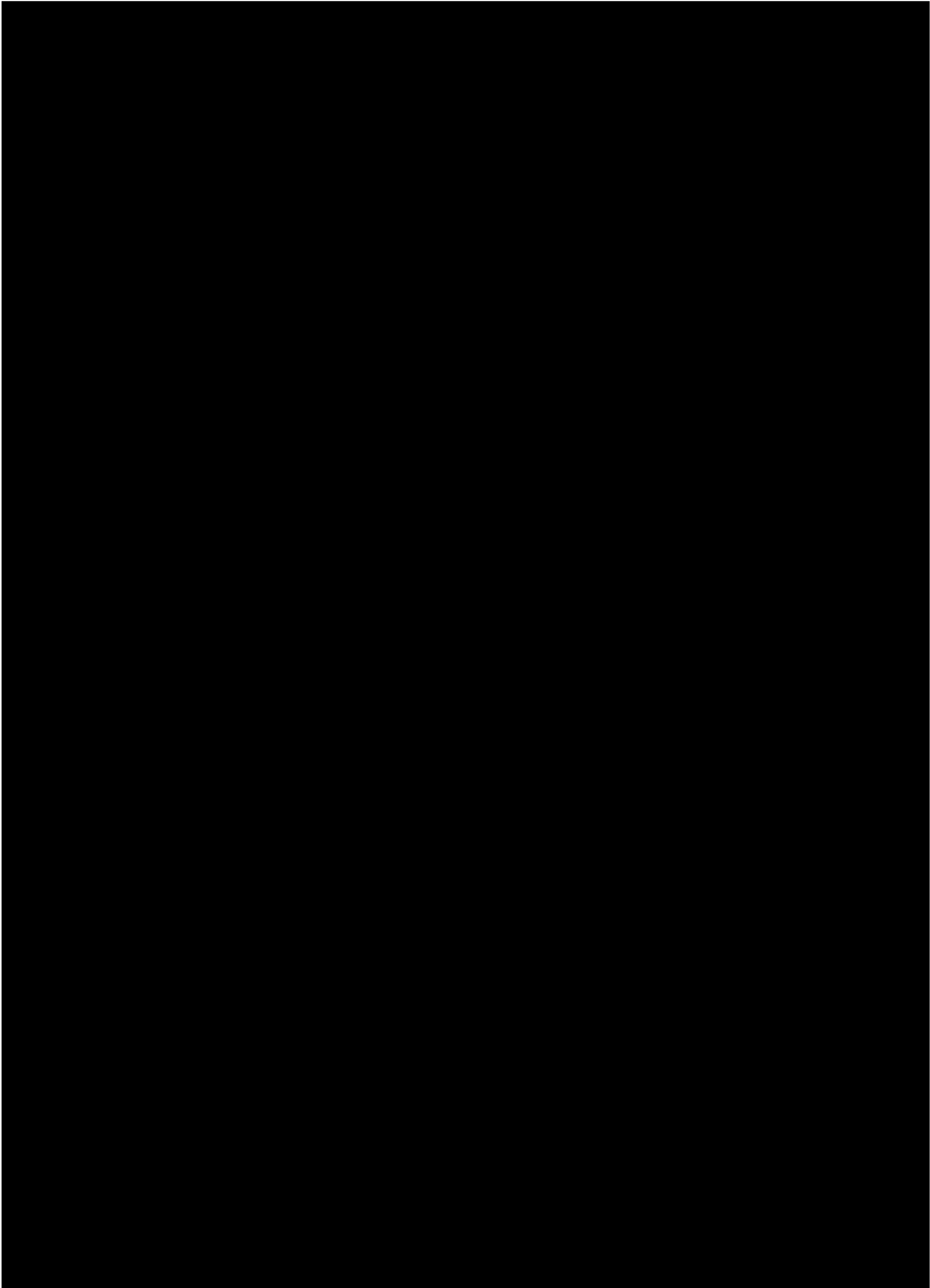

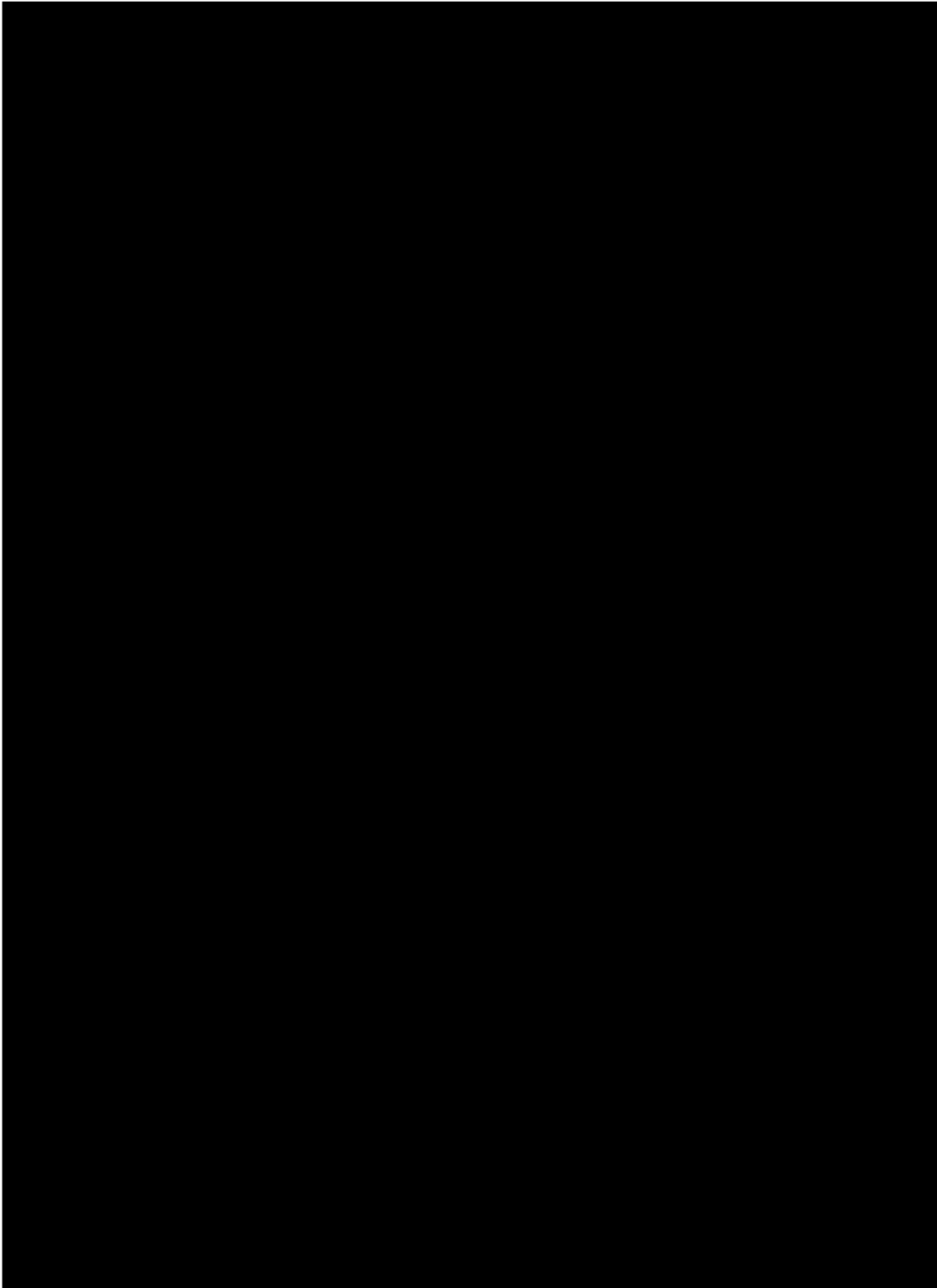
2.3 The actions described under 2.1 through 2.2 are referred to as the "Transfer" hereinafter.

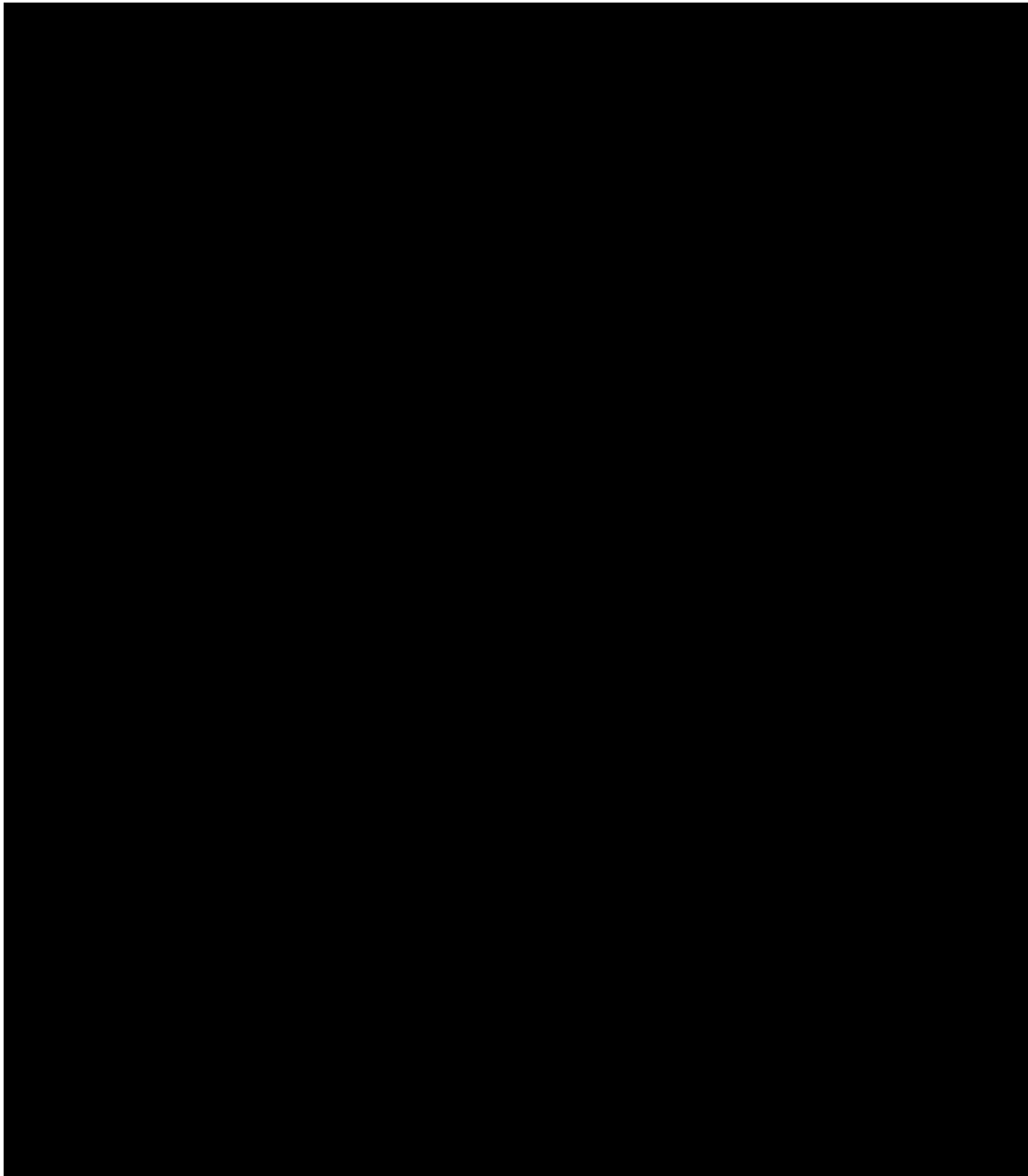
Article 3. Effective date

3.1 The Sale and Transfer shall be effective between the Parties and recorded in their books as per 26 April 2018 (the "Effective Date").











Annex 2 – Residual Kyphon IP

Any or all of the following and all rights, whether statutory or common law, owned by Kyphon, including but not limited to any and all beneficial and/or legal rights, associated therewith:

- a. all domestic and foreign patents and applications therefor and all reissues, reexaminations, divisions, renewals, extensions, continuations and continuations-in-part thereof;
- b. all inventions (whether patentable or not), invention disclosures, improvements, trade secrets, confidential or proprietary information, know how, technology, data and customer lists, rights of privacy and publicity, financial and marketing data, pricing and cost information, business and marketing plans, databases and compilations of data, and all documentation relating to any of the foregoing;
- c. all copyrights, copyright registrations and applications therefor, unregistered copyrights, and the content of all websites and all other rights corresponding thereto throughout the world;
- d. all mask works, mask work registrations and applications therefor;
- e. all industrial designs and any registrations and applications therefor;
- f. all trade names, corporate names, logos, trade dress, trade secret, common law trademarks and service marks; trademark and service mark registrations and applications therefor;
- g. all computer software including all source code, object code, firmware, development tools, files, records and data, all media on which any of the foregoing is recorded, and all documentation related to any of the foregoing; and
- h. all internet domain names (including all software and applications, and all components and/or modules thereof);
- i. any other registered or unregistered intangibles of Kyphon which are not listed in Annexes 1 and 2, and which are not part of the License Agreement, with the exception of goodwill.
