RELEASE OF SECURITY INTEREST IN TRADEMARKS

May 15, 2018

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 15, 2018 (this "Release"), is made by **CIT BANK, N.A.**, in its capacity as administrative agent for the holders of the Obligations (in such capacity, the "Administrative Agent"), in favor of **ROSE OF TEXAS HOSPICE OF HOUSTON, LLC** ("Rose"), a Texas limited liability company, **CIMA HEALTHCARE L.P.** ("CIMA"), a Texas limited partnership, and **CARECYCLE SOLUTIONS, LLC** ("Carecycle"), a Delaware limited liability company (each a "Grantor" and, collectively, the "Grantors"). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement (as defined below).

WHEREAS, Rose and CIMA and/or its affiliates entered into that certain Second Amended and Restated Credit and Guaranty Agreement dated as of August 9, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), with various financial institutions and the Administrative Agent, providing for the extensions of credit to be made to the Grantors by the Lenders;

WHEREAS, pursuant to the Agreement, Rose and CIMA executed and delivered to the Administrative Agent (i) that certain Trademark Security Agreement dated as of August 9, 2016, which was recorded with the United States Patent and Trademark Office on August 9, 2016, at Reel 5853 Frame 0362 and (ii) that certain Trademark Security Agreement dated as of August 9, 2016, which was recorded with the United States Patent and Trademark Office on March 27, 2017 at Reel 6019 Frame 0914, as amended by that certain Reaffirmation of and First Amendment to Trademark Security Agreement dated as of March 10, 2017, executed and delivered by the Grantors to the Administrative Agent, which was recorded with the United States Patent and Trademark Office on March 27, 2017 at Reel 6019 Frame 0907 (collectively (i) and (ii), as so amended, the "Grants"); and

WHEREAS, pursuant to the Grants and the Agreement, each Grantor granted to the Administrative Agent a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising: (i) each trademark, trademark application, and trademark registration owned by such Grantor, together with any reissues, continuations or extensions thereof and all goodwill associated therewith; (ii) each trademark license to which such Grantor is a party, together with all goodwill associated therewith; and (iii) all products and proceeds of the foregoing, including without limitation, any claim by such Grantor against third parties for past, present or future infringement of any such trademark, including, without limitation, each trademark, trademark application and trademark registration identified on Schedule A attached hereto (collectively, the "Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the satisfaction of the obligations secured by the Trademark Collateral having been repaid or otherwise satisfied to the extent set forth in the payoff letter dated on or about the date of this Release and given by the

Administrative Agent, the Administrative Agent, without representation, warranty or recourse, hereby terminates and releases its continuing security interest in the Trademark Collateral including, without limitation, each trademark, trademark application and trademark registration identified on Schedule A attached hereto, effective as of the date set forth above.


The Administrative Agent acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
