## RELEASE OF SECURITY INTEREST IN TRADEMARKS

May 15, 2018

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 15, 2018 (this "Release"), is made by **CIT BANK, N.A.**, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Agent"), in favor of **NATIONAL HOME HEALTH CARE CORP.** ("NHHCC"), a Delaware corporation, **OP HOSPICE, LLC** ("OP"), a Michigan limited liability company, and **GREAT LAKES HOME HEALTH SERVICES, INC.** ("Great Lakes"), a Michigan corporation (each a "Grantor" and, collectively, the "Grantors"). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Guaranty and Security Agreement (as defined below).

**WHEREAS**, **BW GL HOLDINGS, INC.**, a Delaware corporation, **NHHCC** and such other Persons joined thereto as a Borrower from time to time (each a "Borrower" and together, the "Borrowers"), the Grantors from time to time party thereto, the Lenders from time to time party thereto and the Agent entered into that certain Credit Agreement, dated as of December 8, 2016 (as amended, restated, supplemented and/or modified from time to time, the "Credit Agreement");

**WHEREAS**, each Grantor agreed, pursuant to that certain Guaranty and Security Agreement, dated as of December 8, 2016, in favor of Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement") to guarantee the Obligations (as defined in the Credit Agreement) of each Borrower;

**WHEREAS**, pursuant to the Guaranty and Security Agreement, (i) **NHHC** and Agent entered into that certain Trademark Security Agreement dated as of December 8, 2016, which was recorded with the United States Patent and Trademark Office on December 9, 2016, at Reel 5944 Frame 0604, (ii) **OP** and Agent entered into that certain Trademark Security Agreement dated as of December 8, 2016, which was recorded with the United States Patent and Trademark Office on December 9, 2016 at Reel 5944 Frame 0627, and (iii) **Great Lakes** and Agent entered into that certain Trademark Security Agreement dated as of December 8, 2016, which was recorded with the United States Patent and Trademark Office on December 9, 2016, at Reel 5944 Frame 0597 (collectively (i), (ii) and (iii), the "Grants"); and

**WHEREAS**, pursuant to the Grants and the Guaranty and Security Agreement, each Grantor mortgaged, pledged and hypothecated to the Agent for the benefit of the Secured Parties, and granted to the Agent for the benefit of the Secured Parties a Lien on and continuing security interest in, and a right to set off against, (the foregoing, the "Security Interest") all of such Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Grants) including, without limitation, each trademark, trademark application and trademark registration identified on Schedule A attached hereto (collectively, the "Trademark Collateral").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the satisfaction of the obligations

secured by the Trademark Collateral having been repaid or otherwise satisfied to the extent set forth in the payoff letter dated on or about the date of this Release and given by the Agent, the Agent, without representation, warranty or recourse, hereby terminates and releases its Security Interest in the Trademark Collateral including, without limitation, each trademark, trademark application and trademark registration identified on Schedule A attached hereto, effective as of the date set forth above.


The Agent acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
