RELEASE

THIS RELEASE is given and made this 21st day of September, 1998 by Co-Bank, ACB, successor in interest to the Springfield Bank for Cooperatives, having a regional office at 67 Hunt Street, Agawam, Massachusetts ("Co-Bank") to and in favor of: (i) Agrilink Foods, Inc., formerly known as Curtice-Burns Foods, Inc., having its executive offices at 90 Linden Oaks, Rochester, New York ("Agrilink Foods"), (ii) Pro-Fac Cooperative, Inc., having its executive offices at 90 Linden Oaks, Rochester, New York ("Pro-Fac"), (iii) Curtice Burns Express, Inc., (iv) Curtice-Burns Meat Snacks, Inc., (v) Finger Lakes Packaging Company, Inc., (vi) Husman Snack Foods Company, Inc., (vii) Kennedy Endeavors, Incorporated, (viii) Nalley's Canada Limited, (ix) Quality Snax of Maryland, Inc., (x) Seasonal Employers, Inc., Pro Fac Holding Company of Iowa, Inc. and (xi) the successors and assigns of the foregoing (the entities listed above in (i) through (xi) inclusive are hereinafter referred to collectively as the "Debtors").

1. **Background.** Pursuant to a Term Loan, Term Loan Facility and Seasonal Loan Agreement dated as of November 3, 1994 (the "Loan Agreement") CoBank acquired a security interest in substantially all of the assets of the Debtors, including but not limited to all accounts, chattel paper, general intangibles, including trademarks, patents, instruments, securities, inventory, equipment and real property of every kind and description (collectively, the "Assets"), such security interest being evidenced by, among other things, the (a) the Borrower Security Agreement by and among PF Acquisition Corp., Curtice-Burns Foods, Inc. and Co-Bank, dated as of November 3, 1994 (the "Security Agreement"), (b) the Trademark Collateral Assignment and Security Agreement between Curtice-Burns Foods, Inc. and Co-Bank, dated as of November 3, 1994 (the "Trademark Security Agreement"), (c) the Patent Collateral Assignment and Security Agreement between Curtice-Burns Foods, Inc. and Co-Bank, dated as of November 3, 1994 (the "Patent Security Agreement"), (d) the Parent Security Agreement between Pro-Fac and Co-Bank, dated as of November 3, 1994 (the "Parent Security Agreement") and (e) the Subsidiaries Security Agreement by and among Curtice-Burns Express, Inc., Curtice-Burns Meat Snacks, Inc., Finger Lakes Packaging Company, Inc., Husman Snack Foods Company, Inc., Kennedy Endeavors, Incorporated, Nalley's Canada Limited, Quality Snax of Maryland, Inc., Seasonal Employers, Inc., Pro-Fac Holding Company of Iowa, Inc. and Co-Bank, dated as of November 3, 1994 (the "Subsidiaries Security Agreement"). The Security Agreement, the Trademark Security Agreement, the Patent Security Agreement, the Parent Security Agreement and the Subsidiaries Security Agreement shall hereinafter be referred to collectively as the "Security Agreements."

2. **Acknowledgment of Satisfaction of Indebtedness.** Co-Bank hereby acknowledges receipt of payment in complete and full satisfaction of any and all debts, liabilities and obligations of every kind of Agrilink and of the other Debtors due and owing to Co-Bank, except in all respects to the obligations and liabilities of Agrilink Foods to Co-Bank pursuant to the Guaranty dated June 30, 1997 of the obligations of Great Lakes Kraut Company LLC to Co-Bank. The foregoing acknowledgment being subject in all respects to any obligations (including without limitation any environmental indemnity obligations) of the Debtors to Co-Bank under the Loan Agreement, the Security Agreements and any and all other agreements ("Other Agreements") executed and delivered by the Debtors to Co-Bank pursuant to the terms of the Loan Agreement or the Security Agreements (including without limitation any and all mortgages) to the extent such obligations survive pursuant to the terms of the Loan Agreement, the Security Agreements or the Other Agreements.

3. **Release.** In consideration of the premises above and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Co-Bank, intending to be legally bound, hereby releases all of its right, title and interest in and to all of the Assets referenced in the Security Agreements, the Loan Agreement and otherwise encumbering the Assets. The security interest of Co-Bank in the Assets is hereby unconditionally released. The Release specifically covers the following Assets which are specifically identified below for the purposes of filing this Release with the United States Patent and Trademark Office and such other foreign patent and/or trademark offices to insure that this Release is properly recorded in such offices and not for purposes of limiting the breadth of the Release:

(a) all trademarks and service marks listed on the attached Exhibit A and the goodwill symbolized by such marks; and

(b) all patents listed on the attached Exhibit B.

4. **Additional Documentation.** Co-Bank hereby agrees to execute and deliver at the request of one or more of the Debtors, such additional documents, statements and certifications reasonably necessary to effectuate the Release, including but not limited to UCC-3 financing statements and discharges of mortgages and deeds of trust.

IN WITNESS WHEREOF, Co-Bank, ACB by and through its duly authorized representative has duly executed, and does hereby deliver, this Release as of the day and year first above written.
