
WHEREAS, as a result of the foregoing merger, NERD CORPS became the sole and exclusive owner of any and all assets and property belonging to each of the Merging Parties.

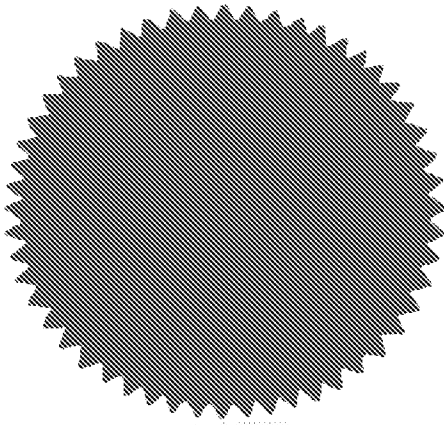
