It is hereby certified that:

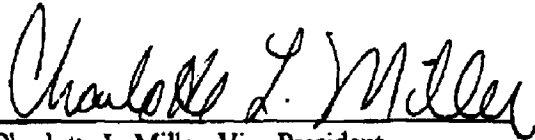
1. The name of the corporation (hereinafter called the "corporation") is JB's Restaurants, Inc.
