ARTICLE I
COMPANY NAME

The name of the corporation (the "Corporation") is KAUFFMAN TIRE, INC.

ARTICLE II
AMENDMENT

Effective as of the date hereof, the Articles of Incorporation of the Company shall be amended by deleting Article I in its entirety and substituting in lieu thereof the following:

"ARTICLE I

ARTICLE III
ADOPTION
