**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of May 17, 2018 (the "Release"), is made by CIBC Bank USA (f/k/a The Private Bank and Trust Company) (the "Lender") in favor of FMG Suite, LLC (f/k/a Faulkner Media Group, LLC), a Delaware limited liability company ("FMG"), Advisors Assistant Holdings, Inc., a Delaware corporation ("Assistant"), and Advisor Launchpad, Inc. (f/k/a FVisions Acquisition Corp), a Nevada corporation ("Launchpad"); collectively with FMG and Assistant, the "Grantors" and each a "Grantor").

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of January 12, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Loan and Security Agreement"), by and among the Grantors, Lender, and others party thereto, that certain Intellectual Property Security Agreement dated January 12, 2017, by and among the Grantors and Lender ("IP Security Agreement #1"), and that certain Intellectual Property Security Agreement dated August 21, 2017, by and among the Grantors and Lender ("IP Security Agreement #2"; together with the Loan and Security Agreement and the IP Security Agreement #2, the "Security Agreements"; capitalized terms used herein are used as defined in the Security Agreements), Grantors granted to Lender a security interest in all of Grantors' right, title, and interest in, to and under certain intellectual property assets, including, without limitation, the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Collateral");

WHEREAS, the IP Security Agreement #1 was recorded at the United States Patent and Trademark Office ("USPTO") on January 13, 2017 at Reel 5965 Frame 0632, and IP Security Agreement #2 was recorded at the USPTO on August 22, 2017 at Reel 6134 Frame 0659; and

WHEREAS, any and all secured obligations as defined by the Security Agreements have been satisfied, and the requirements of the Security Agreements for discharge of the security interests in the Released Collateral have been satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Agreements, and hereby terminates, cancels, and releases any and all security interests it holds in the Intellectual Property Collateral, including without limitation the Released Collateral and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof. Lender hereby acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantors. Lender authorizes the Grantors or their designees to record this Release with the USPTO and any other applicable registry at the sole expense of the Grantors and agrees to provide the Grantors or their designees with any information and additional authorization necessary to effect the release of its security interests in the Released Collateral.


