**AMENDED AND RESTATED SECURITY INTEREST IN TRADEMARKS**

This AMENDED AND RESTATED SECURITY INTEREST IN TRADEMARKS ("Agreement") is made as of May 23, 2018, by WHITE CASTLE MANAGEMENT CO., a Delaware corporation, having an office at 555 West Goodale Street, Columbus, Ohio 43216-1498 (the "Grantor") in favor of JPMORGAN CHASE BANK, N.A., a national banking association, having an office at 100 East Broad Street, 10th Floor, OH 1-0170, Columbus, OH 43215, in its capacity as collateral agent (the "Collateral Agent") for the Creditors (as defined in the Intercreditor Agreement).

PRELIMINARY STATEMENT

WHEREAS, the Grantor entered into that certain Amended and Restated Credit Agreement dated as of date hereof (as from time to time, amended, modified, or supplemented from time to time, the "Credit Agreement") (all capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement), between the Grantor, White Castle System, Inc., an Ohio corporation ("WC System"), White Castle Distributing LLC, a Delaware limited liability company ("WC Distributing"), White Castle Purchasing Co., a Delaware corporation, White Castle Licensing Co., a Delaware corporation, White Castle Food Product, LLC, an Ohio limited liability company, Ingram Food Incorporated, an Ohio corporation, White Castle International, LLC, an Ohio limited liability company, White Castle Investment Co., a Delaware corporation, White Castle Michigan LLC, a Michigan limited liability company, White Castle Indiana LLC, an Indiana limited liability company, and White Castle Kentucky LLC, a Kentucky limited liability company, JPMorgan Chase Bank, N.A. (in its capacity as administrative agent), and the Lenders (as therein defined).

WHEREAS, on or around August 14, 2013, WC System and WC Distributing entered into a Note Agreement (as may be amended or modified from time to time, the "Note Agreement") in favor of the purchasers a party thereto (together with all successors and assigns, collectively, the "Purchasers").

WHEREAS, the Collateral Agent and the Purchasers are entering into an Amended and Restated Intercreditor and Collateral Agency Agreement dated as of the date hereof (as may be amended, restated, or otherwise modified from time to time, the "Intercreditor Agreement").

WHEREAS, to secure the performance of the Borrowers' obligations under the Credit Agreement and the Note Agreement, the Grantor entered into that certain Amended and Restated Pledge and Security Agreement dated as of the date hereof, by which the Grantor granted to the Collateral Agent, for the benefit of the Creditors, a security interest in and to all trademarks, trademark registrations and applications and the goodwill symbolized thereby currently owned by the Grantor or acquired by the Grantor after such date; and

WHEREAS, the Grantor is the owner of the trademarks, trademark registrations, and trademark applications listed on Exhibit A, and the goodwill symbolized thereby, and the parties wish to document the security interest granted to the Collateral Agent, for the benefit of the Creditors, with respect thereto;

NOW THEREFORE, the Grantor hereby grants to the Collateral Agent, for the benefit of the Creditors, a security interest in and to the trademarks, trademark registrations, and trademark applications listed in **Exhibit A**, and authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to note in the record the existence of the security interest granted hereunder with respect to each of the trademark registrations and applications listed in **Exhibit A**.


