**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of May 31, 2018, and made by **ZB, N.A. dba CALIFORNIA BANK AND TRUST** (the "Grantee"), to **mTAB LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of February 7, 2017 made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on February 21, 2017 at Reel/Frame 5993/0116; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks, including, without limitation, those listed on Schedule A hereto


2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.

3. Recordation of Release. Grantee understands and agrees that this Termination may be recorded by or for the Grantor with the United States Patent and Trademark Office.
