RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of May 31, 2018, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (“Lender”), in favor of ISI DESIGN AND INSTALLATION SOLUTIONS, INC., a Maryland corporation (f/k/a Creative Touch Interiors, Inc.) (“Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantor has, pursuant to that certain Trademark Security Agreement dated May 31, 2016, recorded in the United States Patent and Trademark Office (the “USPTO”) on June 16, 2016 at Reel 5815, Frame 0225 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreement”) granted to Lender a Security Interest in and to all of each Grantor’s right, title and interest, including goodwill, in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and


B. WHEREAS, Lender wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates and releases, without recourse, representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Lender acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Lender authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
