This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT ("Termination and Release") dated as of June 1, 2018, from Emigrant Bank, as secured party (in such capacity, the "Lender") to Westport Capital Partners LLC, a Connecticut limited liability company (the "Pledgor"). WHEREAS, the Lender now desires to terminate and release its security interest in the Trademarks and reassign any and all rights, title, and interest in the same to the Pledgor.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Lender hereby releases its security interest in all of Pledgor's right, title and interest in and to the Trademarks.
