**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of April 23, 2018, is executed by Bank of America, N.A. in its capacity as administrative agent (the "Administrative Agent"), in favor of Image Source, Inc., a Missouri corporation (the "Borrower"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Trademark Security Agreement, dated as of August 30, 2010 (as amended, the "Security Agreement"), by and between Borrower and Administrative Agent, Borrower granted to Administrative Agent a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on August 31, 2010 at Reel/Frame 4270/0069 to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to execute this Termination in order to evidence the termination and release of its security interest in the IP Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent's right, title and interest in, to and under the following (collectively, the "IP Collateral"):

(i) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1, together with any reissues, continuations or extensions thereof and all goodwill associated therewith; and

(ii) all products and proceeds of the foregoing, including, without limitation, any claim by the Borrower against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1, any trademark issued pursuant to a trademark application referred to in Schedule 1.


(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the trademark division of the United States Patent and Trademark Office to record this Termination.
