## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") dated as of April 26, 2018 is made by WILMINGTON TRUST, NATIONAL ASSOCIATION ("Wilmington Trust", as successor to Oaktree SC Dealersocket Agent, LLC ("Oaktree SC")), as administrative agent (in such capacity, the "Administrative Agent") in favor of DEALERSOCKET, INC., a Delaware corporation, NELEVEN, LLC, a Wisconsin limited liability company, FINANCE EXPRESS, LLC, a Nevada limited liability company, and AUTOSTAR SOLUTIONS, INC., a Texas corporation (collectively, the "Grantors").

### WITNESSETH

WHEREAS, the Grantors and Oaktree SC are parties to that certain Guaranty and Security Agreement dated as of February 11, 2016 (as from time to time amended, restated, supplemented or otherwise modified, the "Guaranty and Security Agreement");

WHEREAS, the pursuant to the Guaranty and Security Agreement, the Grantors executed that certain (a) Trademark Security Agreement dated as of February 11, 2016 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on February 11, 2016 at Reel/Frame Nos. 5729/0639, 5729/0654, 5729/0663 and on May 6, 2016 at Reel/Frame No. 5789/0004, (b) Patent Security Agreement dated as of February 11, 2016 (the "Patent Security Agreement") and recorded with the USPTO on February 11, 2016 at Reel/Frame No. 37718/0118, (c) Copyright Security Agreement dated as of February 11, 2016 (the "Copyright Security Agreement," and collectively with the Trademark Security Agreement and Patent Security Agreement, the "IP Security Agreements") and recorded with the U.S. Copyright Office ("USCO") on March 11, 2016 at V9934 D057, pursuant to which the Grantors unconditionally granted, collaterally assigned, and pledged to Oaktree SC a continuing security interest in all of Grantors' right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), Patent Collateral (as defined in the Patent Security Agreement), and Copyright Collateral (as defined in the Copyright Security Agreement); and


WHEREAS, pursuant to that certain (a) Amendment No. 1 to Trademark Security Agreement dated as of March 11, 2016 (the "Trademark Amendment") and recorded May 22, 2016 with the USPTO at Reel/Frame Nos. 5798/0470, 5798/0477, 5798/0483, 5798/0490, (b) Amendment No. 1 to Patent Security Agreement dated as of March 11, 2016 (the "Patent Amendment") and recorded March 17, 2016 with the USPTO at Reel/Frame No. 38143/0933, and (c) Amendment No. 1 to Copyright Security Agreement dated as of March 11, 2016 (the "Copyright Amendment," and collectively with the Trademark Amendment and the Patent Amendment, the "Amendments") and recorded March 30, 2016 with the USCO at V9933 D454, Oaktree SC assigned to Wilmington Trust all of its right, title, and interest in, to, and under the Trademark Collateral, Patent Collateral, and Copyright Collateral.

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title, and interest in, to, and under the Trademark Collateral, Patent Collateral, and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title, and interest in, to, and under the Trademark Collateral, Patent Collateral, and Copyright Collateral, including the trademark registrations, patent, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral, Patent Collateral, and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral, Patent Collateral, and Copyright Collateral under the IP Security Agreements and the Amendments.
