GRANT OF TRADEMARK SECURITY INTEREST

WHEREAS, OLD WORLD INDUSTRIES, LLC, an Illinois limited liability company ("Grantor"), owns and uses in its business, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

WHEREAS, pursuant to that certain Credit Agreement dated as of March 29, 2018 (as it may be amended, restated, supplemented or otherwise modified from time to time, being the "Credit Agreement") by and among Wells Fargo Strategic Capital, Inc., with a place of business located at 1000 Louisiana St., 9th Floor, Houston, Texas 77002, individually as a Lender and as administrative agent (in such capacity, "Administrative Agent") for itself and all other Lenders from time to time a party thereto ("Lenders"), all other Lenders, Old World Industries Holdings, LLC, an Illinois limited liability company ("Holdings"), Old World Industries, LLC, an Illinois limited liability company ("Old World Industries"), Old World Global, LLC, an Illinois limited liability company ("Old World Global") and Old World Sanders Road, LLC, an Illinois limited liability company ("Old World Sanders Road" and together with Holdings, Old World Industries and Old World Global, "Borrowers", and each a "Borrower"), Lenders have extended a credit facility to Borrowers. Each term used herein but not otherwise defined herein shall have the meaning assigned to such term in the Credit Agreement; and

WHEREAS, Borrowers may from time to time enter, or may from time to time have entered, into one or more Hedge Agreements with one or more Hedge Banks or one or more Cash Management Agreements with one or more Cash Management Banks; and

WHEREAS, pursuant to the terms of a Security Agreement dated as of March 29, 2018 (as it may be amended, restated, supplemented or otherwise modified from time to time, being the "Security Agreement"), among Grantor, Administrative Agent and the other grantors named therein, Grantor has created in favor of Administrative Agent a security interest in, and Administrative Agent has become a secured creditor with respect to, the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantor to Administrative Agent pursuant to the Security Agreement, Grantor hereby grants to Administrative Agent a security interest in all of Grantor's right, title and interest in and to the following, in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located (the "Trademark Collateral"):

- (i) all rights, title and interest in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor in its business (including, without limitation, the trademarks set forth on Schedule A annexed hereto) (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries (including, without limitation, the registrations and applications set forth on

Schedule A annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and

(ii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Administrative Agent is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "proceeds" includes whatever is receivable or received when Trademark Collateral or proceeds are sold, licensed, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

This Grant of Trademark Security Interest has been executed and delivered by the Grantor for the purpose of recording the grant of security interest in the Trademark Collateral with the U.S. Patent and Trademark Office. The security interest granted herein has been granted to the Administrative Agent in connection with the Security Agreement and does not create any additional rights or obligations for any party hereto or thereto. Grantor does hereby further acknowledge and affirm that the rights and remedies of Administrative Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference and to which this Grant of Trademark Security Interest is expressly subject.

Notwithstanding anything herein to the contrary, the lien and security interest granted to Wells Fargo Strategic Capital, Inc. pursuant to this Grant of Trademark Security Interest and the exercise of any right or remedy by Wells Fargo Strategic Capital, Inc. hereunder are subject to the provisions of the Intercreditor Agreement, dated as of March 29, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement"), among Wells Fargo Bank, National Association, as First Lien Administrative Agent, and Wells Fargo Strategic Capital, Inc., as Second Lien Administrative Agent. In the event of any conflict between the terms of the Intercreditor Agreement and this Grant of Trademark Security Interest, the terms of the Intercreditor Agreement shall govern and control.
