RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of June 1, 2018 (this “**Release**”), is made by OWL ROCK CAPITAL CORPORATION, as Administrative Agent and Collateral Agent for the Secured Parties (in such capacities and together with its successors and permitted assigns, the “**Administrative Agent**”) under that certain Trademark Security Agreement, dated as of June 12, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”) by and among ATTENTUS MEDICAL SALES, INCORPORATED, a Texas corporation with an address of 5750 North Sam Houston Parkway East, Houston, TX 77032 (the “**Grantor**”) and the Administrative Agent. Unless otherwise defined herein, terms defined in the Trademark Security Agreement and used herein have the meaning given to them in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on June 12, 2017 at reel 6081, frame 0854, the Grantor granted to the Administrative Agent a continuing security interest in all of the Grantor’s right, title and interest in or to any and all of its owned or thereafter acquired Trademark Collateral (as defined therein), including those set forth on the attached Schedule A; and


WHEREAS, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) release and terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release and terminate its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral.


