## RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS RELEASE** of Trademark Security Agreement (this "Release") is executed as of March 29, 2018, by Credit Suisse AG, Cayman Islands Branch, as collateral agent (the "Collateral Agent") for the Secured Parties, for the benefit of (i) ECI Holding (Hungary) Korlátolt Felelősségű Társaság; (ii) Telecom Investments (Finance) LLC; (iii) ECI Telecom DND, Inc.; and (iv) ECI Telecom Inc. (collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the Trademark Security Agreement (as defined below).

**WHEREAS**, pursuant to a Trademark Security Agreement, dated as of December 14, 2007 (the "Trademark Security Agreement"), between the Grantors and the Collateral Agent, which Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on January 30, 2008 at Reel 003707, Frame 0519, the Grantors have granted a security interest in its respective right, title and interest in and to the trademarks and trademark applications listed in Annex 1 hereto (the "Trademarks") to the Collateral Agent; and

**WHEREAS**, in connection with the discharge of all liabilities and obligations, the Secured Parties have agreed to release the security interests created under the Trademark Security Agreement on the terms and conditions set forth in that certain Global Deed of Release, dated as of March 29, 2018, between, *inter alios*, the Collateral Agent and the Grantors.


