RELEASE OF SECURITY INTEREST IN TRADEMARKS



WHEREAS, Grantor has promptly paid and performed all its Secured Obligations (as defined in the Security Agreement), and Agent desires to release its security interests in and liens upon the Trademarks and Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby releases its lien on and security interest in and to the Trademarks and Licenses and all good will associated therewith and reassigns any and all interest it may have in such Trademarks and Licenses to Grantor and CIW, as the case may be.
