RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, pursuant to that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of August 11, 2016 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 5854, Frame 0936; and Reel 039431, Frame 0134, WALZ GROUP, LLC, a Delaware limited liability company with offices located at 27398 Via Industria Avenue, Temecula, California 92590 (Riverside County) (the "Releasee"), granted unto COMPASS BANK, an Alabama banking corporation, as the Administrative Agent for the Secured Parties (in such capacity, together with its successors and assigns, if any, the "Releasor"), for the ratable benefit of the Secured Parties, a security interest in all of Releasee's right, title and interest in and to the Collateral, including without limitation with respect to the patents, trademarks and copyrights listed on the attached Schedule A, as collateral security for the prompt and complete payment and performance when due of such Releasee's Secured Obligations; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Intellectual Property Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.
2. Release of Security Interest. Releasor hereby releases to Releasee, and releases to the Releasee on behalf of the Secured Parties, its security interest in the Collateral.
