## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of April 20, 2018, by and between CAPITAL ONE, NATIONAL ASSOCIATION, a United States national banking association with offices located at 299 Park Avenue, Floor 23, New York, NY 10171, as lender ("Lender"), and TMP WORLDWIDE ADVERTISING & COMMUNICATIONS, LLC, a Delaware limited liability company with offices located at 7800 West Brown Deer Road, Suite 400, Milwaukee, WI 53223 ("Debtor"). Reference is hereby made to that certain Trademark Security Agreement between the Debtor and the Lender dated as of June 30, 2014 (the "IP Security Agreement"), recorded at the United States Patent and Trademark Office at Reel 5315, Frame 0355 on July 2, 2014. Terms used but not defined in this Release shall have the meanings given thereto in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Agent was granted a security interest in and to certain collateral, including the Trademarks listed on Schedule 1 (the "Trademark Collateral");

WHEREAS, the Debtor has requested that the Agent terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office (the "USPTO"); and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in and to the Trademark Collateral. Debtor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.


