**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Intellectual Property Assignment Agreement (this "IP Assignment") is made and entered into as of August 1, 2016 (the "Effective Date") by Accenture Global Services Limited, a company incorporated in Ireland under registration number 285869 ("Assignor"), and Duck Creek Technologies Limited with its registered office at 30 Fenchurch Street, London, United Kingdom, EC3M 3BD ("Assignee"). Assignor and Assignee are referred to herein collectively as the "Parties" and each individually as a "Party". Capitalized terms used but not defined herein shall have the meanings set forth in the Transaction Agreement (as defined below).

RECITALS

WHEREAS, certain Affiliates of Assignor and certain other Persons are parties to that certain Transaction Agreement, dated April 14, 2016 (the "Transaction Agreement") whereby an Affiliate of Assignor has agreed to cause this IP Assignment to be executed immediately prior to the Closing; and

WHEREAS, Assignor desires to transfer, convey, assign and deliver to Assignee, and Assignee wishes to accept from Assignor, the Transferred IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Defined Terms. Each capitalized term used in this Agreement but not defined in this Agreement has the meaning given to such term in the Transaction Agreement.

2. Assignment. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee, and Assignee hereby accepts from Assignor, all of Assignor's legal, beneficial and other right, title and interest in and to the Transferred IP, including (i) the Intellectual Property set forth on Appendix A attached hereto (ii) the goodwill symbolized thereby and, with regard to any trademarks included in the Transferred IP that are intent to use applications, the Parties acknowledge that the portion of Assignor's business in respect of which Assignor has a bona fide intent to use such marks is also being transferred pursuant and subject to the Transaction Agreement, and (iii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to: (A) apply for and maintain all registrations, renewals and/or extensions thereof, (B) bring actions and recover damages for past, present and future infringement or other violation thereof and (C) grant licenses or other interests therein.

3. Subject to Transaction Agreement. This Agreement is made without representation or warranty, except as provided in the Transaction Agreement. Each of the Parties hereby acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the Transaction Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Transaction Agreement and the terms hereof, the terms of the Transaction Agreement shall govern and control.

4. Miscellaneous.

(a) This IP Assignment shall be governed by and construed in accordance with the Laws of the State of Delaware applicable to contracts executed and to be performed wholly within such State and without reference to the choice-of-law principles that would result in the application of the Laws of a different jurisdiction. Each Party irrevocably submits to the exclusive jurisdiction of the Court of Chancery of the

State of Delaware (or, solely if such court declines jurisdiction, in any federal court located in the State of Delaware) any Action arising out of or relating to this IP Assignment, and hereby irrevocably agrees that all claims in respect of such Action may be heard and determined in such court. Each Party hereby irrevocably waives, to the fullest extent that it may effectively do so, the defense of an inconvenient forum to the maintenance of such Action. The Parties further agree, (i) to the extent permitted by Law, that final and non-appealable judgment against any of them in any Action contemplated above shall be conclusive and may be enforced in any other jurisdiction within or outside the United States by suit on the judgment, a certified copy of which shall be conclusive evidence of the fact and amount of such judgment and (ii) that service of process upon such Party in any such Action shall be effective if notice is given in accordance with Section 4(b), below. Each Party to this IP Assignment waives trial by jury in any Action brought by any of them against the other arising out of or in any way connected with this IP Assignment, or any other agreements executed in connection herewith or the administration thereof or any of the transactions contemplated herein or therein. No Party to this IP Assignment shall seek a jury trial in any Action based upon, or arising out of, this IP Assignment or any related instruments or the relationship between the Parties. No Party will seek to consolidate any such Action in which a jury trial has been waived with any other action in which a jury trial cannot be or has not been waived. Each Party to this IP Assignment certifies that it has been induced to enter into this IP Assignment or instrument by, among other things, the mutual waivers and certifications set forth in this Section 4(a). No Party has in any way agreed with or represented to any other Party that the provisions of Section 4(a) will not be fully enforced in all instances.

(b) All notices and other communications to be given to Assignee or Assignor hereunder shall be sufficiently given for all purposes hereunder if in writing and upon delivery if delivered by hand, one (1) Business Day after being sent by email, four (4) Business Days after being sent by courier or overnight delivery service, seven (7) Business Days after being mailed by certified or registered mail, return receipt requested, with appropriate postage prepaid, or when sent in the form of a facsimile and receipt confirmation is received, and shall be directed to the address or facsimile number set forth below (or at such other address or facsimile number as such either Assignee or Assignor shall designate for itself by like notice to the other party):

(d) The section and article headings contained in this IP Assignment are inserted for convenience of reference only and will not affect the meaning or interpretation of this IP Assignment.

(e) If any term, provision, covenant or restriction of this IP Assignment is held by a court of competent jurisdiction or other authority to be invalid, void or unenforceable, the remainder of the terms, provisions, covenants and restrictions of this IP Assignment shall remain in full force and effect and shall in no way be affected, impaired or invalidated so long as the economic or legal substance of the transactions contemplated hereby is not affected in any manner materially adverse to any Party. Upon such a determination, the Parties shall negotiate in good faith to modify this IP Assignment so as to effect the original intent of the Parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the fullest extent possible.

(f) Assignor and Assignee shall each be responsible for payment of its own taxes.
