The name of the converting entity, a Louisiana corporation, is TASTEE #38, INC. The name of the converted entity, a Louisiana Limited Liability Company will be TASTEE #38, LLC.

1. The resulting converted entity will be a limited liability company governed by Louisiana Revised Statutes Title 12, Chapter 22.
2. The converting entity is continuing its existence in the form of the converted entity.
3. The outstanding shares of common stock held by each shareholder of the converting entity shall be converted into a percentage membership interest in the converted entity equal to such shareholder's ownership interest in the converting entity determined by dividing the number of shares of common stock held by such shareholder by the total number of outstanding shares of common stock held by all shareholders of the converting entity.
4. The conversion has been authorized and approved by the unanimous written consent of the Board of Directors and the Shareholders of the converting entity in accordance with Louisiana Revised Statutes Title 12, Chapter 25, Section 1601, *et seq.*
5. The Effective date of the conversion is upon the filing with the Secretary of State.
6. The articles of organization and initial report of the converted entity are as follows:

ARTICLE I

The name of the limited liability company (the "Company") is TASTEE #38, LLC

ARTICLE II

The purpose of this Company is to engage in any lawful activity for which limited liability companies may be formed under the Louisiana Limited Liability Company Law, La. R.S. 12:1302 *et seq.*

ARTICLE III

The business of this Company shall be managed by one or more managers, who may but need not, members of the Company. Except as authorized by managers, no member is an agent of the Company or has the authority to bind the Company, make any contract, enter into any transactions, or make any commitments on behalf of the Company.

ARTICLE IV

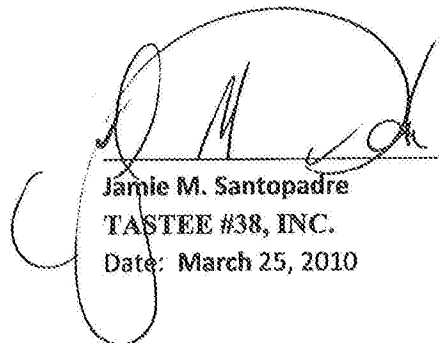
The term of the Company shall be perpetual.

No oral agreement among any of the members of the Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Company, as amended and in existence from time to time.

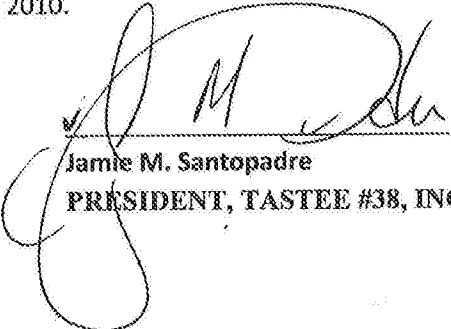
