**TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY**

WHEREAS J.S.N. Jewellery Inc., a Canadian corporation with principal offices at 64 Jardin Drive, Unit 7, Concord, Ontario, Canada, L4K 3P3 (the “Grantor”) entered into a Credit Agreement dated July 18, 2013, as amended, replaced, restated or supplemented from time to time (the “Credit Agreement”) with Salus Capital Partners, LLC (acting as agent and lender), with a principal office at 197 First Avenue, Suite 250, Needham, Massachusetts, United States of America, 02494 (the “Creditor”);

AND WHEREAS as security for its obligations to Creditor, Grantor provided: (i) a security agreement dated July 18, 2013, which granted Creditor security over all of its assets located in the United States of America (the “U.S. Security Agreement”); and (ii) a Canadian general security agreement dated July 18, 2013, which granted Creditor security over all of its assets located in the Canada (the “GSA”);

AND WHEREAS these grants of security interests included a grant of security interest in and to (*inter alia*) the Grantor’s intellectual property, including, without limitation, the trademarks listed in Schedule “A” hereto (the “Trademarks”), and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement;

AND WHEREAS the U.S. Security Agreement was recorded on July 30, 2013 at the United States Patent and Trademark Office at Reel 5080, Frame 0908; and the GSA was recorded on April 14, 2016 by the Canadian Intellectual Property Office (with evidence on record at file number 1655572);

AND WHEREAS, the Creditor has agreed to terminate and release its security interest in all such Trademarks as herein provided.


