RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this “Release”) is made as of November 10, 2017 (“Effective Date”) by ZD Holding, LLC (the “Secured Party”), as successor in interest to The Peninsula Fund IV Limited Partnership (the “Prior Secured Party”), in favor of ClingZ, Inc. (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Intellectual Property Security Agreement (as defined below), as applicable.

WHEREAS, Grantor and the Prior Secured Party entered into that certain Intellectual Property Security Agreement dated May 22, 2008 (the “Intellectual Property Security Agreement”), under which Grantor granted to the Prior Secured Party a security interest in and mortgage upon, all of Grantor’s right, title and interest in, to and under the Collateral, including the items listed on Schedule A hereto, and such Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on June 30, 2008, at Reel 021174, Frame 0641 and at Reel 3806, Frame 0478;

WHEREAS, the Prior Secured Party and the Secured Party entered into that certain Assignment of Loan Documents dated November 4, 2014 (the “Assignment”), under which the Prior Secured Party assigned all of its rights under the Intellectual Property Security Agreement to the Secured Party, and such Assignment was recorded with the United States Patent and Trademark Office on December 21, 2016, at Reel 041128, Frame 0162 and at Reel 5950, Frame 0305;

WHEREAS, Grantor has satisfied the terms of the Intellectual Property Security Agreement and requests a specific release of the security interest granted and recorded against the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby (i) terminates the Intellectual Property Security Agreement, (ii) releases any and all security interests, right, title and interest the Secured Party may have in, to or under the Collateral, and (iii) re-assigns to Grantor, any right, title or interest the Secured Party may have in, to or under the Collateral, together with the goodwill of the business symbolized thereby.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
