**RELEASE AND REASSIGNMENT OF

Reference is hereby made to (i) that Memorandum and Notice of Security Interest in Intellectual Property, dated as of October 14, 2016, executed by Duckhorn Wine Company, a California corporation, ("Debtor"), whose address is 1000 Lodi Lane, St. Helena, CA 94574, in favor of Bank of the West, a California corporation ("Secured Party"), whose address is 300 South Grand Avenue, 5th Floor, Los Angeles, CA 90071, which was recorded in the United States Patent and Trademark Office (the "USPTO") on October 17, 2016, at Reel 5927 Frame 0094 (the "Initial Agreement"); and (ii) that certain Amendment Number One (Second Lien) to Memorandum and Notice of Security Interest in Intellectual Property, dated as of October 27, 2017, executed by Debtor, in favor of Secured Party, which was recorded in the USPTO on October 30, 2017, at Reel 6209 Frame 0994 (the "Subsequent Agreement", and together with the Initial Agreement, collectively, the "Agreements"), and pursuant to which the Debtor assigned and granted to Secured Party a security interest in and to all of Debtor's right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "Trademarks") and the goodwill associated therewith; and

WHEREAS, Secured Party wishes to terminate the Agreement and release, retransfer and reassign to Debtor, or its successor in interest, without representation or warranty, all of Secured Party's right, title and interest in and to the Trademarks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby terminates the Agreement and releases, retransfers and reassigns to Debtor, or its successor in interest, without representation or warranty, any and all liens, security interests, right, title and interest of Secured Party in and to the Trademarks and the goodwill associated therewith.
