## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is effective as of June 6, 2018 (the "Effective Date"), by and between Valeant Pharmaceuticals Luxembourg Sàrl, a société à responsabilité limitée existing under the laws of the Grand Duchy of Luxembourg having a registered office at 13-15 Avenue de la Liberté, Grand Duchy L-1931, Luxembourg ("Assignor") and Valeant Pharmaceuticals Ireland Limited, a limited company established and existing under the laws of Ireland having its registered office at 3013 Lake Drive, Citywest Business Campus, Dublin 24, Ireland ("Assignee").

**WHEREAS**, Assignor is the owner of the U.S. Trademark Applications and Registrations listed on **Schedule A** (the "Assigned Trademarks"); and the goodwill associated with the Assigned Trademarks; and

**WHEREAS**, Assignor wishes to assign to Assignee and Assignee to receive all of Assignor's right, title, and interest in and to the Assigned Trademarks, and the goodwill associated with the Assigned Trademarks; and

**WHEREAS**, Assignor has assigned to Assignee the portion of Assignor's business to which the Assigned Trademarks pertain, which is ongoing and existing.

**NOW, THEREFORE**, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment. It being the intention of the parties that Assignee shall acquire all rights in the Assigned Trademarks, leaving Assignor with no rights whatsoever, Assignor does hereby sell, convey, assign, and transfer to Assignee all of Assignor's right, title and interest in and to (i) the Assigned Trademarks, together with the goodwill associated thereto, and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto, including, without limitation, all of Assignor's rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement, conflict, or other violation thereof, and (c) grant licenses or other interests therein.
2. Successors and Assigns. This Agreement and all its provisions shall be binding upon and inure to the benefit of the parties hereto and their respective permitted successors and assigns.
3. Governing Law. This Agreement shall be governed in all respects by the laws of the State of New York, without giving effect to the principles of conflicts of law thereof.
4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.
5. Descriptive Headings. The descriptive headings of the several articles and sections of this Agreement are inserted for reference only and shall not limit or otherwise affect the meaning hereof.

6. Severability. If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction or other governmental authority to be invalid, void or unenforceable, the remainder of the terms, provisions, covenants and restrictions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated so long as the economic or legal substance of the transactions contemplated hereby is not affected in any manner materially adverse to either party. Upon such a determination, the parties shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in an acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the fullest extent possible.
