DEED OF TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is made on 23 May 2018

BETWEEN:

In consideration of the sum of £1 (ONE POUND) (receipt of which the Assignor expressly acknowledges) the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Trade Marks, including all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods and services in respect of which the Trade Marks are registered and/or used; and the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from the ownership of the Trade Marks whether occurring before, on or after the date of this Assignment.

(2) THIRD PARTY RIGHTS


No person other than a party to this Assignment shall have any rights to enforce any term of this Assignment.






