RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of the 5 of June, 2018, by CIT BANK, N.A. in its capacity as administrative agent for the benefit of the Lenders (in such capacity, the "Agent"), pursuant to the Security Agreement (as defined below), in favor of PRONTO HOLDCO LLC, a Delaware limited liability company, PRONTO GENERAL AGENCY, LTD., a Texas limited partnership, PRONTO FRANCHISE, L.L.C., a Texas limited liability company, PRONTO INSURANCE AGENCIES, LP, a Texas limited partnership, INSURANCE INTERNET SYSTEMS, LP, a Texas limited partnership, PRONTO INSURANCE AGENCY OF LAREDO, INC., a Texas corporation, CKR INSURANCE AGENCY, LLC, a Texas limited liability company, PRONTO GENERAL AGENCY MANAGEMENT, LLC, a Texas limited liability company, VELA HOLDINGS I GP, LLC, a Texas limited liability company, and VELA HOLDINGS II GP, LLC, a Texas limited liability company (collectively, the "Grantors").

WITNESSETH

WHEREAS, Agent and Grantors are parties to a certain Intellectual Property Security Agreement, dated as of September 30, 2014 (the "Security Agreement"; capitalized terms not otherwise defined herein shall have the respective meanings assigned to them in the Security Agreement), wherein Grantors granted Agent, among other collateral as set forth therein, a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule A attached hereto (the "Trademarks"), for the benefit of the Secured Parties.

WHEREAS, pursuant to the provisions of the Security Agreement, a Security Interest in Trademarks was recorded with the U.S. Patent and Trademark Office on September 30, 2014, at Reel 5371 and Frame 0871;

WHEREAS, Grantors have satisfied the terms of the Security Agreement and request a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Agent desires to grant to Grantors a specific release of the security interest granted and recorded against each Trademark.

NOW THEREFORE, for good and valuable consideration previously tendered by Grantors, the receipt and sufficiency of which are hereby acknowledged, Agent does hereby:


1. terminate, release and reassign to the Grantors any and all liens, security interests, right, title and interest of Agent pursuant to the Security Agreement in the Trademarks, together with the goodwill of the business symbolized thereby; and
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

The validity, interpretation and enforcement of this Release of Security Interest in Trademarks shall be governed by the laws of the State of New York (without reference to its choice of law rules).
