
Dear Jason:

You and we have been members and partners of (1) the musical group professionally known as "Metallica", which has operated as a California general partnership; (2) We're Only In It for The Music, a California general partnership which has ventured with Elektra Entertainment in E/M Ventures to own certain Metallica master recordings; and (3) Creeping Death Music, a fictitious business name of the We're Only In It For The Music general partnership which owns and administers certain copyrights and music publishing interests (collectively, the "**Group**"). On January 8, 2001 you dissociated as a partner of the Group by notifying us of your withdrawal from the Group.

By this agreement the parties desire (1) to specify the terms governing termination of the professional and partnership relationship between you and us, including the termination of your participation in the Group, effective as of January 1, 2001 (the "**Termination Date**"); and (2) to release each other from all claims, obligations and duties arising out of such relationship, except as otherwise provided below. Accordingly, you and we agree as follows:

1. Withdrawal.

(a) Except as specifically set forth herein, you hereby relinquish your entire interest in the Group and its assets as of the Termination Date, including your partnership interests in the Group. In this regard, within thirty days after the execution hereof, the parties shall file a Statement of Dissociation pursuant to Section 16704 of the California Uniform Partnership Act of 1994 (the "CUPA").
