## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release"), dated as of April 16, 2018, is made by SUNTRUST BANK, as administrative agent ("Agent") for itself, its successors and permitted assigns, and the Secured Parties (as defined in the Security Agreement referred to below) in favor of Wolverine Brass, Inc., a Delaware corporation ("Wolverine") and Plumbmaster, Inc., a Delaware corporation ("Plumbmaster" and together with Wolverine, collectively the "Grantors" and each a "Grantor").

**WHEREAS**, pursuant to (i) the Guaranty and Security Agreement, dated as of December 23, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among Professional Plumbing Group, Inc., a Delaware corporation (the "Borrower"), the Grantors, the Agent and the other parties party thereto, and (ii) the Trademark Security Agreement, dated as of December 23, 2016 (the "Trademark Security Agreement"), by and among the Grantors and Agent, the Grantor has granted a continuing security interest in and continuing lien upon the trademark registrations and trademark applications shown on Schedule A (the "Trademarks");

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on December 23, 2016 at Reel 5951 Frame 0342; and

**WHEREAS**, Agent (acting at the direction of the Lenders) now desires to terminate and release the entirety of its security interest in the Trademarks.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent (for itself and as Agent for the Lenders) and the Grantors agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement as the context may require.

**SECTION 2. Termination and Release.** The Agent (acting at the direction of the Lenders), for itself and as Agent for the Lenders, hereby:

(a) terminates, releases, and discharges its continuing security interest in and continuing lien upon the Trademarks. Any and all right, title, or interest of Agent in the Trademarks and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademarks and any and all causes of action which may exist by reason of infringement of the Trademarks, shall hereby cease and become void;

(b) authorizes the recordation of this Release with the USPTO;

(c) releases without any recourse to the Agent (whether as Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the undersigned (whether as Agent or in its personal capacity); and

(d) agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.

This release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
