ASSIGNMENT OF TRADEMARK INTEREST

WHEREAS, Assignor is the owner and holds all right, title and interest in U.S. Trademark Registration Number 4280805 for the mark 4TH GENERATION issued by the U.S. Patent and Trademark Office on January 22nd, 2013, and any applications and existing registrations therefore and any logos, designs, graphics or other marks or indicators of origin used by Assignor in connection with the operation of its business (hereinafter the "Trademark"); and

WHEREAS, Assignor has agreed to assign to Assignee, and Assignee accepts such assignment from Assignor, of fifty (50) percent of all right, title, and interest in, to and under the Trademark, together with the goodwill of the business connected with the use of and symbolized by the Trademark;

NOW THEREFORE, and incorporating all above paragraphs as part of this agreement, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, Assignor hereby assigns, transfers and conveys to Assignee fifty (50) percent of its right, title and interest in, to and under the Trademark, and any associated applications and registrations therefore, together with the goodwill of the business connected with the use of and symbolized by the Trademark.

Assignor further represents and warrants that it has not transferred, assigned, hypothecated or granted a security interest in the Trademark to any third party.




Further, Assignor agrees to execute and provide promptly after the execution hereof, such further instruments, documents or assignments as may be reasonably necessary to effectuate the purposes of this transaction and to consolidate, vest and record in Assignee its rights in, to and under the Trademark.
